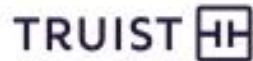

Barry DuVal **President & CEO** **Virginia Chamber of Commerce**

Barry DuVal was named President and CEO of the Virginia Chamber of Commerce on April 28, 2010. His public service began in 1988 when he was elected to the Newport News City Council. In 1990 he was elected mayor of the city. He served as mayor from 1990 through 1996, when he stepped down to become the President and CEO of a regional economic development organization representing Southeast Virginia's 1.6 million citizens.

Mr. DuVal served as the Secretary of Commerce and Trade for the Commonwealth of Virginia from 1998 through 2002. During his term as Secretary, Virginia attracted a record-setting 1,500 economic development projects representing 156,850 new jobs and \$13.7 billion in private investment.

His private sector experience includes serving as President and CEO of DuVal Associates, Inc, a diversified real estate firm which he cofounded with his father in 1983. Additionally, he served as President and CEO of Kaufman & Canoles Consulting, LLC, an economic development consulting firm from 2002 until joining the Virginia Chamber of Commerce as President & CEO in 2010.

Mr. DuVal is a graduate of James Madison University and American University's Washington College of Law.

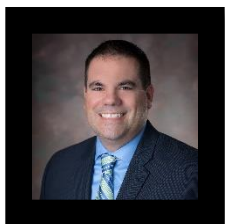

Edward H. "Ed" Baine is president–Dominion Energy Virginia.

He is responsible for all facets of Dominion Energy Virginia, a vertically integrated electric utility with generation, transmission and distribution assets that provides electric service to about 2.7 million customer accounts in Virginia and northeastern North Carolina.

Baine joined the company in 1995 as an associate engineer and since has held numerous engineering, operational and management positions. He was promoted to vice president–Shared Services in 2009 and became vice president–Power Generation Merchant Operations in 2012. He became vice president–Power Generation System Operations in 2013 and senior vice president–Transmission & Customer Service in 2015. In 2016, he was named senior vice president–Distribution, Power Delivery Group. He was named senior vice president—Power Delivery, Dominion Energy Virginia in 2019 and assumed his current position in October 2020.

Baine is a member of the boards of directors of the Dominion Energy Credit Union, ChamberRVA, Venture Richmond, and CJW Medical Center. In addition, he serves on the board of visitors at Virginia Tech and the boards of directors of the Southeastern Electric Exchange, the Virginia Tech Athletic Fund, MEGA Mentors, The Valentine museum, as well as on the executive committees of the EPRI Research Advisory and AEIC Power Delivery.

He earned his bachelor's degree in electrical engineering from Virginia Tech and completed the advanced management program at Duke University's Fuqua School of Business. He is a registered professional engineer in Virginia.

and as vice president of research, engineering, and technical services at the National Rural Electric Cooperative Association (NRECA) in Arlington, Virginia. At NRECA, Hewa and his teams worked to advance the adoption of beneficial smart grid technologies among the nation's electric cooperatives focusing on reliable, resilient and clean and distributed energy tech adoption. At NRECA, he also worked with federal agencies including the RUS and DOE to address co-op technical regulatory issues. Virginia Natural Gas

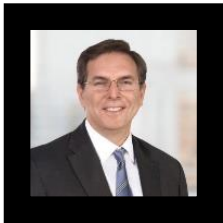

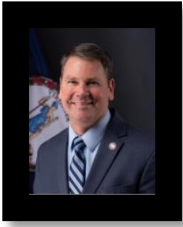


Brooks Smith

The Honorable Matt Lohr

Virginia Secretary of Agriculture and Forestry

Matthew Lohr was raised on a Virginia century family farm in the Shenandoah Valley. As a fifth-generation farmer, he has spent his entire life working for the betterment of the agricultural industry and rural America.

Matthew developed his passion for public service and agricultural policy while serving as both a state and national FFA officer before graduating from Virginia Tech with a B.S. degree in Agricultural Education. He has more than 30 years of experience as a professional leader and communicator.

Over the past two years, Matthew has served as the Chief of the USDA-Natural Resources Conservation Service, an agency with more than 10,000 employees across 3,000 field offices and an operating budget of over \$4.5 billion.

Matthew previously served in the Virginia House of Delegates from 2006-2010 before being appointed as the Commissioner of the Virginia Department of Agriculture and Consumer Services. His other career experiences include serving as Director of the Farm Credit Knowledge Center, teaching middle school agriscience, operating his own leadership development company, and serving as President of Valley Pike Farm, Inc., his family's farming operation.



Mike Rolband

Director

Virginia Department of Environmental Quality

Director Mike Rolband joined DEQ in January 2022. He founded Wetland Studies and Solutions Inc. (WSSI) in 1991 and grew his company into a multidisciplinary natural and cultural resources consulting firm with a staff of more than 200. Rolband is a P.E., PWD, PWS Emeritus and LEED AP. His firm constructed the first LEED Gold facility in Virginia and utilized multiple Low Impact Development practices for stormwater management in 2005.

In 2014, WSSI was acquired by The Davey Tree Expert Co. and, under Rolband's leadership, expanded to include offices in Maryland and across Virginia. WSSI assisted land developers and public works agencies navigate the Clean Water Act, Chesapeake Bay Preservation Act and local environmental regulations.

Rolband's lifelong interest in wetlands and stormwater management and its interaction with natural waterbodies has led to changes in Virginia environmental laws. He has testified before the General Assembly and lectured to numerous organizations on stormwater management and mitigation, wetlands and stream regulatory policy and Chesapeake Bay Preservation Act regulations.

Rolband was instrumental in developing Virginia's new wetlands laws in 2000 and served on the technical advisory committee that developed subsequent regulations. He was also involved in developing the new stormwater regulations and the energy balance method of stormwater quantity control. He has been appointed to a number of advisory boards and stakeholder groups. The 2021 Virginia General Assembly honored Rolband and his extensive contributions through unanimous passage of Senate Joint Resolution 371.

Rolband established the nonprofit Wetland Research Initiative in 2007 to fund applied research in wetlands creation, restoration and enhancement activities. It and a companion effort – the Stream Restoration Initiative – are both managed through the Resource Protection Group Inc., a 501(c)(3) organization Rolband founded in 2012.

In 2017, Rolband was named a Professor of Practice by Cornell University, where he enjoyed teaching and mentoring engineering students through August 2020, and giving back to his alma mater, where he received his BS (Civil and Environmental Engineering), M. Eng, and MBA.



Travis Voyles

Acting Secretary of Natural and Historic Resources

Travis Voyles serves as the Acting Secretary of Natural and Historic Resources for Virginia Governor Glenn Youngkin. He previously served as Oversight Counsel for the U.S. Senate Committee on Environment and Public Works under Senator Shelley Moore Capito of West Virginia. In this role, he served as the lead coordinator of the Committee's efforts for environmental, energy, economic development, and infrastructure issues, including primary oversight over a wide range of federal agencies programs and funding (DOT, EPA, Army Corps, DOE, FWS, NRC, EDA). He also provided cross-cutting technical and legal input on legislative efforts, including the recent Bipartisan Infrastructure Law and budget reconciliation efforts.

Prior to working in the Senate, he served in multiple appointed roles at the U.S. Environmental Protection Agency, including Acting Associate Administrator for the Office of Congressional and Intergovernmental Relations and Director of Oversight. In these roles he managed all congressional interactions and investigations on issues pertaining to EPA rulemakings, policies, ethics, appropriations, and the Senate confirmation process for nominees. He also served as the chief liaison between the Agency, the EPA Administrator, and other national, state, and local officials. Travis has also worked for the U.S. House of Representatives Committee on Science, Space, and Technology.
